I understand that, if I am seated as a Grand Juror, I will be available to attend grand jury meetings and devote the required time to complete grand jury work for one year, from July through June. I further understand that, if my name is drawn as an alternate, I will remain available for one year to serve as a member of the grand jury.

I understand that a grand juror must attend required plenary meetings, be an active member on investigative committees, and participate in the investigation process (Jurors spend the majority of their time researching, reading, reference material, interviewing, and writing and editing reports) These activities require an average of 20 to 30 hours a week. If selected I will be able to devote the required time and effort to the activities of the grand jury?  Yes  No

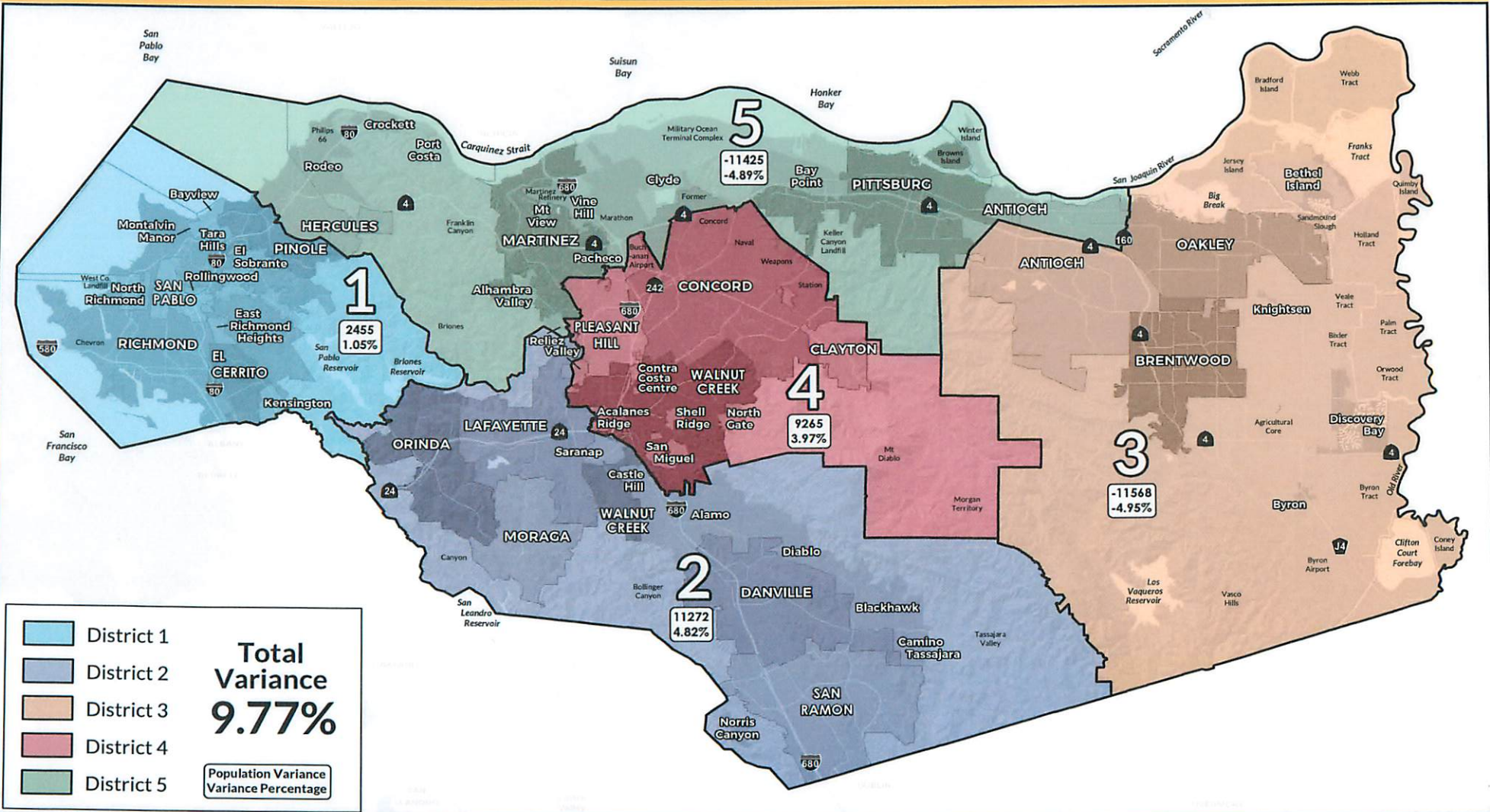

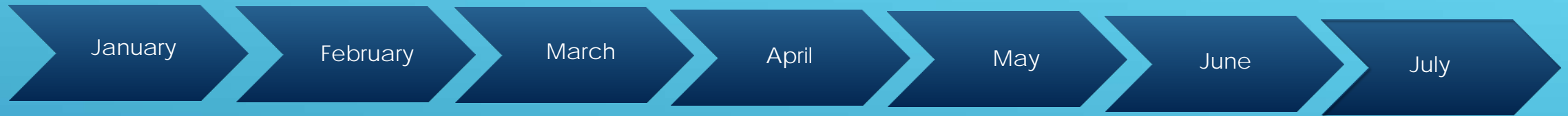
