The County's ambulance franchisee, American Medical Response, sends a paramedic unit to each medical call in Richmond; however, our fire companies usually arrive first.
9. Respondent partially disagrees with the finding. Richmond Fire and Crockett Fire provide BLS. All other West County fire departments provide ALS.


13. Respondent disagrees with the finding. For the last year, July 11, 2006- July 11 2007, when comparing auto aid responses - Richmond Fire into County jurisdiction and CCCFPD into Richmond - Richmond Fire responds into Contra Costa County areas at a ratio of 1.73 to 1.
14. Respondent disagrees with the finding. Richmond Fire and El Cerrito Fire respond to electronic fire alarms using 3 engines, 1 truck and 1 Battalion Chief. The CCCFPD responds to these alarms with two engines.

18. Respondent partially disagrees with the finding. If all goes according to plan and the various jurisdictions continue to pursue an interoperable communication system, it may be completed within 3-5 years.

The biggest challenge was that the Contra Costa County Fire Protection District was not interested in working collaboratively with us to resolve response issues. There was also no interest in training, common dispatching, working the same shift schedule, or compensation to the city of Richmond for services provided. The Richmond Fire Department was expected to provide fire service into North Richmond, San Pablo, East Richmond Heights and El Sobrante at no cost to the County (See #26).
