The conditions are as follows:

1. Defendant shall obey all laws and follow all orders of the Court.
2. Pay a diversion administrative fee of **\$300**, payable through Linebarger.
3. Defendant shall engage in a program of drug education and/or counseling as directed by the Court and cooperate in such program and not withdraw from such program until authorized to do so by the Court.
4. Defendant shall notify their probation officer of any change of address, telephone number or place of employment within 5 days of such change.
5. Defendant shall not use, possess any cannabis, controlled substances, narcotics or narcotic paraphernalia without a prescription from a licensed physician.
6. Defendant shall report to the police agency, as directed, to be booked for the offense(s).
7. Defendant shall pay victim restitution in the amount of \$ _____, plus a fee in the amount of 15% of the victim restitution pursuant to 1203.1(l), if not paid forthwith.
8. Defendant shall abstain from the use of alcohol.
9. Do not own or possess or control any firearm or weapon.
10. Defendant understands and agrees with the terms of diversion. BAIL, IF POSTED, IS ORDERED EXONERATED. Defendant, if in custody on this docket, is to be released.
11. Upon successful completion of deferred cases, please refer to section 1000.4 of the Cal. Penal Code regarding "Disclosure of Arrest" rights.
